Eligibility Criteria for Admission:

A Bachelor's Degree with Major/Honours in Zoology, Botany, Biotechnology, Microbiology, or similar discipline from a recognized University, along with a valid GAT-B 2025 Score. Instructions for admission into the DBT-supported M.Sc. in Molecular Biology and Biotechnology (MBBT) Program- 2025-26 at Cotton University, Guwahati, Assam

- The candidates are required to check the eligibility criteria before applying for admission to the DBT (GOI)-supported Molecular Biology and Biotechnology Program- 2025 at Cotton University, Assam.
- The candidates **must have qualified** the GAT-B 2025 exam conducted by Regional Centre for Biotechnology (RCB).
- The candidates must ensure to have the necessary supporting documents mentioned below at Annexure C, before initiating the application:

(Annexure A to C)

- Please ensure that all supporting documents are in PDF/JPEG format (except for the photograph) and are less than 2MB each in size.
- A merit list based on GAT-B rank/score will be prepared after the application deadline (see admission schedule).
- Admission to M.Sc. in the MBBT program will be done solely based on the valid GAT-B-2025 score/rank [conducted by the Regional Centre for Biotechnology (RCB), Govt of India] of the candidate.
- The candidates have to apply for admission through the online portal that can be accessed from the University website (<https://admissions.cottonuniversity.ac.in/>). **There is no provision for an offline application/registration to the program and admissions will be done online as well.**
- The candidates are advised to regularly visit the University website (<https://cottonuniversity.ac.in>) for any new information/announcements.

Shortlisted candidates are required to accept the admission offer by depositing the **prescribed fee of INR 17,800.00** (Indian Rupees seventeen thousand and eight hundred only) to the University on the specified date of admission, at Cotton University, Guwahati, Assam. Admission will be offered after physical verification of the documents. An online payment link will be intimated in due course of time.

In case a candidate either refuses the offer or does not pay the prescribed fee on the date of admission, the offer will be withdrawn; the seat will be treated as vacant and will be offered to the next candidate as per the University admission and reservation policy.

Merit List Preparation:

The Merit List for selection of admission will be prepared based on the GAT-B rank/score of the year 2025. In case of more than one candidate with identical GAT-B score, the following criteria will be used to resolve and determine inter-se-merit of candidates, in the stated order.

- i. In the highly unlikely event of candidates having the same GAT-B rank/score the candidate with higher CGPA/ percentage in the last qualifying examination will be given preference
- ii. In the unlikely event of candidates having the same GAT-B rank/score, and CGPA /percentage, the candidate with the earlier Date of Birth will be given preference.

Gap in Study

Students passing the qualifying examination or other degree/diploma examination (under recognized institution) earlier than the current year will have to submit a self-declaration testifying his/her activities during the interim period.

Information regarding clarification on various points (Documents, Certificates, Affidavit, Undertaking etc.)

- a) The latest EWS / OBC-NCL certificate (issued on or after **1st April 2025**) is required to be uploaded for online document verification.
- b) Candidates unable to obtain the latest EWS / OBC-NCL certificate can upload the last issued EWS/OBC-NCL certificate along with an affidavit during the application process (Refer to **Annexure A** for Affidavit regarding EWS, **Annexure B** for Affidavit regarding OBC-NCL) on the portal.
- c) The list of documents to be produced by the candidates at the time of admission to the M.Sc in MBBT programme, Cotton University, Guwahati, Assam are detailed in **Annexure C**.
