IMPORTANT NOTES:

1. The candidates must produce the following documents in original with a set of self-attested photocopy at the time of physical verification on the day of admission:

- Print out copy of application form.
- Pass Certificate and Marksheet of the qualifying examination (HS or equivalent 10+2 examination from a recognized board or council).
- Reserved Category Certificate, if applicable. Only certificates issued by the competent authority under the Government of Assam shall be deemed valid.
- A coloured Passport size photograph (with name written on the backside).
- Age proof: Certificate from authorized official where Date of Birth is mentioned.
- Duly filled up Student's Undertaking Form (to be downloaded from the University website)
- Duly filled up Anti-Ragging Undertaking (to be downloaded from the University website)
- Gap in study: Candidates having passed the qualifying examination in an earlier year (2023, 2022 or 2021) will have to submit a Self-declaration certifying that she/he was not involved in any unlawful activities during the interim period and that she/he would

withdraw admission from any other regular UG course presently enrolled in, if selected for admission.

- (i) Candidates seeking admission under **EWS category** will have to bring valid Income and Asset certificates issued by a competent authority under the Government of Assam.

2. For candidates seeking to avail the **Free Waiver Scheme** kindly read the Government of Assam notification No.490303/2024/9; dated: 01/06/2024 available in the University website. Candidates are also required to download, fill up and submit the Student's Declaration Form available in the website.
