A separate notification shall be issued later for candidates having submitted application for admission in **EC etc. and DA quotas**, to submit all testimonials in support of their claim for the quota.

Cotton University shall not issue any physical application form or brochure from the office. The combined provisional merit list of all applicants shall be displayed on the University website in the evening of **21 September 2021**. The dates of admission/counselling will be notified in the 4<sup>th</sup> week of September. Self-financing courses will not be covered by the fee waiver scheme announced by the Govt of Assam for the year 2021-22.
